





Other effects of massage

In this section you should describe the effects massage has on blood flow, lymph flow, muscle tension, connective tissue, sleep patterns, digestion, blood pressure, pain, mood, concentration, satiety and bonding.

Task 6 – Historical, cultural and philosophical approaches to massage Due Date: 12 - Jun

To complete this assessment task you are required to write a blog post (1 000 - 1500 words) which considers the historical and cultural development of massage. Your post should include

- A comparison of the development of massage in the eastern and western traditions
- The role of Hippocrates, Galen, Ling, Metzger, Kellogg, Vodder, Travell & Cyriax in the development of massage in the western tradition
- A comparison of maori massage (miri miri & romi romi) with western massage
- The massage scandals of the 1800s and their impact on the massage industry
- The development of professional massage in New Zealand including MINZI, NZATMP, TMA & MNZ
- Contemporary massage
- A discussion of how the following philosophical approaches to massage (body, bodymind, body-mind-spirit) relate to the historical and cultural contexts discussed.

Create a client details form

Your client details form must be significantly different from the Otago Polytechnic client details form.

Present your client records to your tutor

In the last two weeks of the semester you must arrange a time with your lecturer to sign-off your logbook. You must bring your client records to this session.

Your client records must show

- evidence of a minimum of 20 hours of massage treatments recorded with a client details form and a S.O.T.A.P. form
- A minimum of five of these records must use the client details form that you've created.

Your records should be legible, use standard terminology and abbreviations, and should record subjective measures of the health and wellbeing status of your clients.
